(3)(a) Each center shall maintain a child-care program that assures each child shall be:

- 1. Provided with adequate supervision at all times by a qualified staff person who ensures the child is:
- a. Within scope of vision and range of voice; or
- b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on interview, a staff person stated that she took her two-year-old class with her when she returned breakfast items back to the kitchen. She stated that she had six or seven two-year-old children with her during that time but they were all seated on the floor in the doorway of the kitchen and were never actually in the kitchen. She stated that after putting the breakfast items away she also did some prep work for lunch by placing a pot on the stove. She stated that the stove was never turned on in the presence of the children. She stated that after approximately ten minutes she took the children back to their classroom. Based on this information, it was determined that the children could not be adequately supervised while the teacher was in the kitchen.

General: Based on review of documentation and interview, the health, safety and comfort of children in care was not maintained. A witness reported seeing a staff person in the kitchen with several two-year-old children during the morning hours on 08/24/2021. After interviewing the staff person in question, it was determined that she was in the kitchen putting away milk and other breakfast items on the morning of the 08/24/2021. She stated that she had six or seven two-year-old children with her during that time but they were all seated on the floor in the doorway of the kitchen and were never actually in the kitchen. She stated that after putting the breakfast items away she also did some prep work for lunch by placing a pot on the stove. She stated that the stove was never turned on in the presence of the children. She stated that after approximately ten minutes she took the children back to their classroom.
