General: Based on review of documentation, three staff members (hire dates: 5/26/2022, 5/30/2022, and 6/22/2022) did not have evidence of completing the required CPR/First Aid training on file at the facility. A review of ECE-TRIS records supports the information found during the survey.

General: Based on review of documentation, the following was found:

1.) A staff member (hire date: 10/1/2021) did not take Orientation training within three months of employment. The course was taken 5/24/2022.

2.) Two staff members (hire dates: 7/20/2019 and 1/13/2020) did not complete the required PAHT training. These staff members have been employed for more than one year.

3.) Three staff members (hire dates: 5/1/2019, 7/20/2019, and 1/31/2020) did not have evidence of completing 15 hours of annual early care and education training on file.
