#### Findings:

General: Based on observation and interview, during a walk-through of the facility, 19 children ages three to four-years-old were observed in the four-year-old room with one staff person. An interview with the staff person in charge found she had been in the room with the staff person but had briefly stepped inside the kitchen to flip sausage patties so they would not burn. The kitchen is located in the middle of the facility and can be entered through the four-year-old room and through the two-year-old room. The staff person in charge stated the person in charge of cooking meals was unloading a vehicle that contained groceries and supplies for the facility. This vehicle was observed by the surveyors upon arrival at the facility. The rear hatch of the vehicle was open and food items were observed in the back of the vehicle. It was also noted that the staff person responsible for cooking met the surveyors at the door leading into the two-year-old room. The surveyors observed the staff person in charge come from the kitchen and into the two-year-old room.

## Findings:

General: Based on interview with the staff person in charge, it was found every day she transports a staff person's child to kindergarten. She also indicated that she brings another staff person's child and the staff person in charge's nephew back to the facility. The facility is not currently licensed for transportation. Therefore, the facility is providing a service for which they have not been approved.
