General: Based on Review of Documentation, the child care center failed to comply with regulatory requirements. Review of documentation revealed four (4) children's medication authorization forms listing the name of the children and their medications were posted on the wall under the bulletin board in the foyer of the Infant/Toddler Building, open to public view. Review of documentation in the Older Twos Room revealed one (1) child's medication form listing the name of the child and the medication was posted on a cabinet, open to public view.

Findings:

General: Based on Observation, the child care center director failed to assure compliance with regulatory requirements. Observation of the Crawlers Room revealed a three-month-old infant lying awake in a bouncy chair that was placed inside a crib. Observation of the Younger Twos/Older Twos and the Preschool 2 bathrooms revealed a plunger next to the toilet, accessible to children in care.
