- (b) Be stored out of reach of a child;
- (c) Be periodically inventoried to ensure the supplies have not expired;
- (d) If reusable, be:
- 1. Sanitized; and
- 2. Maintained in a sanitary manner; and
- (e) Include:
- 1. Liquid soap;
- 2. Adhesive bandages;
- 3. Sterile gauze;
- 4. Medical tape;
- 5. Scissors;
- 6. A thermometer;
- 7. Flashlight;
- 8. Cold pack;
- 9. First aid book;

#### 10. Disposable gloves; and

#### 11. A cardiopulmonary resuscitation mouthpiece protector.

#### Findings:

General: Based on observation, plastic containers filled with first aid supplies were being stored on a wire shelving unit located along the wall near the door used to enter and exit the classroom. The shelves were very low, making the containers of first aid supplies accessible to the children.

A review of documentation found that the program has a third party agreement with the school system. Further review of documentation found that the time each of these children gets off the bus in the morning and each time they board the bus in the afternoon is not being recorded.
