General: Based on observation, interview and review of documentation, a caregiver hired 02/26/2021, supervised six (6) school-age children alone for approximately ten (10) minutes on 04/14/2021. The caregiver was under the age of eighteen and was not under direct supervision of a qualified caregiver, therefore, adequate supervision was not provided

General: Based on observation, interview and review of documentation, a caregiver hired 02/26/2021 supervised six (6) school-age children alone for approximately ten (10) minutes on 04/14/2021. The caregiver was under the age of eighteen and was not under direct supervision of a qualified caregiver, therefore, staff/child ratios were not maintained.

General: Based on observation, interview and review of documentation, a caregiver hired 02/26/2021, did not have processed and approved background checks on file and was left alone and supervised six (6) school-age children for approximately ten (10) minutes on 04/14/2021.

**922 KAR 2:415E. Emergency Regulation.**

**Due to the current declared public health emergency caused by the Novel Coronavirus Disease (COVID-19), licensed child care centers must operate under Centers for Disease Control and Prevention and public health guidelines, as mandated by 922 KAR 2:415E, to prevent the spread of COVID-19.**

**Findings:**

General: Based on observation, interview and review of documentation, the center failed to assure new staff shall undergo name-based background checks in accordance with 922 KAR 2:280 and shall not be left alone with children until fingerprint-based background checks are able to conducted, in accordance with 922 KAR 2:415E. A caregiver hired 02/26/2021, did not have processed and approved background checks on file and was left alone and supervised six (6) school-age children for approximately ten (10) minutes on 04/14/2021.
