Implementation and Enforcement.</p> <p>(1) A person who is a child care staff member prior to January 1, 2018, shall submit to and complete background checks in accordance with this administrative regulation no later than September 30, 2018.</p> <p>(2) A child care staff member hired on or after April 1, 2018, shall:</p> <p>(a) Have completed the background checks required in accordance with this administrative regulation and been found to have no disqualifying offense prior to becoming a child care staff member; or</p> <p>(b) 1. Have submitted to the background checks required in accordance with this administrative regulation;</p> <p>2. Not be left unsupervised with a child in care pending the completion of the background checks in accordance with this administrative regulation; and</p> <p>3. Be dismissed or relocated from the residence if the person is found to have a disqualifying background check result.</p> <p>Findings:</p> <p>General: Based on review of documentation of the KARES report, the surveyor found that a staff (DOH: 04/25/22) submitted to fingerprints and received an eligibility hire date of 04/28/22; however, the staff person was hired on 04/25/22, prior to clearance for employment. During interview, staff-in-charge stated that he was not aware that the staff person had to submit to fingerprints prior to beginning employment.</p> | |
