922 KAR 2:090. Section 8. General.
(1) A licensee shall:
(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and
(b) Protect and assure the health, safety, and comfort of each child.

Findings:

Based on interviews, a caregiver used an open hand to swat a one-year-old child on top of his clothes on the butt after he took another child's goldfish snack at approximately 2:00 p.m. on 04/07/22 in the toddlers' room.

Director Requirements Not In Compliance

350 - Staff Management/Policy Development/Supervision Not In Compliance

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.
(1) A director shall:
(e) Manage the staff in their individual job descriptions;
(f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;
(g) Supervise staff conduct to ensure implementation of program policies and procedures;

Findings:

General: Based on review of documentation and interviews, the center's discipline policy stated staff did not use corporal punishment/physical force to the body, which includes hitting, shaking, biting, pinching, pushing, pulling or spanking. The policy was not followed when a caregiver used an open hand to swat a one-year-old child on top of his clothes on the butt on 04/07/22 in the toddlers' room.
