General: Based on Interview, and record review, the facility did not submit written notification to the cabinet for approval prior to implementation of transportation services. A review of the summer calendar posted in the school age classroom found that children "Catch the Bus" to go to the library every Tuesday and are scheduled to take a "Bus Trip to Kids Place" on 7/24/13. An interview with staff revealed that children are transported via a public bus during these field trips; however, transportation services had not been approved by the Cabinet and it was not listed on the license.

2. A review of the daily schedule posted in the two (2) year old classroom revealed that activities were listed from 9:00AM - 4:00PM. The staff person in charge stated that the facility is open from 6:30AM - 6:00PM; therefore, the schedule does not reflect all hours of operation.
