#### Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulations. Review of staff files revealed two (2) staff members with the hire dates of 09/24/1998 and 04/01/1993 failed to have records of tuberculin result on file. Interview with the director revealed this information as unavailable at the time of survey.

340 - Training Not In Compliance

#### 922 KAR 2:110. Section 5. Staff Requirements.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1  $\frac{1}{2}$ ) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

#### Findings:

General: Based on review of documentation and interview, the child care center failed to maintain employee records in accordance with regulations. Review of staff files revealed a staff member with a hire date 02/15/2017 had not completed state approved orientation training. Interview with the director revealed this documentation was not on file at the time of survey

#### **Findings**

General: Based on observation and interview, the child care center failed to comply with regulations regarding programming. In the infant room there was an eight (8) month old baby in a crib holding a pacifier with a clip attachment of a stuffed animal. Interview with the director revealed she was not aware the stuffed animal pacifier clip was not allowed.

General: Based on observation, the child care center failed to comply with regulations regarding premises. In the three and four-year-old room there was paint chipping away from the wall near the stage

In the ladies' bathroom there was paint chipping away from the window seal.

Further observation revealed in the ladies' bathroom there was dust and cob webs on the stall doors and ceiling air vent.
