b. Any means accepted by a state of prior residency;

2. A check of the state's sex offender registry or repository; and

3. A check of the state-based child abuse and neglect registry and database; and

(b) Direct results of the checks required in paragraph (a) of this subsection to the Department for Community Based Services, Division of Child Care, 275 East Main Street, 3C-F, Frankfort, Kentucky 40601.

Findings:

General: Based on Review of Documentation and interview, a caregiver hired 08/17/18, did not have a criminal records check on file from Illinois, which was a previous state of residence. Interview determined the out-of-state request was never submitted to Illinois.

(a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;

Findings:

General: Based on Review of Documentation and interview, one (1) child enrolled 08/01/18, did not have an immunization certificate on file. One (1) child, enrolled 08/02/18, had an immunization certificate on file that expired 08/15/18, and another child enrolled 08/02/18, had an immunization certificate on file that expired 08/01/18.

1140 - Enrollment Information

922 KAR 2:090, Section 9, Records,

(1) A child-care center shall maintain:

- (b) A written record for each child:
- 1. Completed and signed by the child's parent;
- 2. Retained on file on the first day the child attends the child-care center; and
- 3. To contain:

a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;

b. Contact information to enable a person in charge to contact the child's:

(i) Parent at the parent's home or place of employment;

(ii) Family physician; and

(iii) Preferred hospital;

c. The name of each person who is designated in writing to pick-up the child;

d. The child's general health status and medical history including, if applicable:

(i) Allergies;

(ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and

(iii) Permission from the parent for third-party professional services in the child-care center;

e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;

f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on Review of Documentation, one (1) child enrolled 08/02/18, enrollment information did not include the name of the preferred hospital. One (1) child enrolled 08/02/18, had enrollment information that did not include the name and phone number of the child's physician. One (1) child enrolled 08/02/18, did not have an enrollment form completed and signed by the parent.
