Findings:	
<p>General: Based on interview, two (2) school-age children were out of scope of vision and range of voice from a caregiver for approximately ten (10) minutes beginning at 3:30 p.m. on 03/24/2021. Interviews revealed the two (2) children were between a shed and the school building on the fenced-in playground.</p>

<p>Based on interviews, two (2) school-age children were unsupervised behind a shed for approximately ten (10) minutes on the playground on 03/24/2021. The caregiver discovered the children in an inappropriate position. One (1) child was on the ground on his hands and knees with his face in the area of the other child's private part.</p>
