General: Based on review of documentation, a staff, hired on 01/06/2020, did not have education verification on file.

A staff, hired on 10/01/08, completed one and a half (1 ½) hours of cabinet approved pediatric abusive head trauma training on 02/25/23. A staff, hired on 10/07/18, completed one and a half (1 ½) hours of cabinet approved pediatric abusive head trauma training on 10/04/13. Both staff did not repeat the training as required every five (5) years.

General: Based on review of documentation, four (4) children, first dates of attendance on 08/09/19, did not have information on file to enable the person in charge to contact the child's preferred hospital.

General: Based on review of documentation, monthly, practiced fire drills were conducted January 2019 through May 2019 but the date, time and names of children participants were not documented. Monthly, practiced fire drills were conducted in August 2019 through December 2019 but the names of children participants were not documented. Also, quarterly, practiced earthquake and tornado drills were conducted in the first and second quarter, but the date, time and names of children participants were not documented. Quarterly, practiced earthquake and tornado drills were conducted in the third and fourth quarter, but the names of children participants were not documented.

Quarterly, practiced earthquake and tornado drills were conducted during the first and second quarter of 2019, but were not documented.
