#### Findings:

General: Based on interview and review of documentation, the child care center failed to maintain employee records. A review of staff files failed to reveal educational requirements for staff members with hire dates of 8/23/2020, and 9/28/20. Interview with the staff in charge revealed the documentation was not available at the time of the survey.

Interview with the staff in charge revealed the documents were not available at the time of the survey.
