Observation revealed at approximately 3:40 pm two school age children walked from a hallway that was perpendicular to the hallway that led into the Cafeteria unsupervised. Further observation revealed the director, site leader, and four staff members were supervising twenty six children already present in the Cafeteria when the two additional children arrived. Interview with the center's director revealed the two school age children were transported to the location site for the program by bus from another school. Continued interview with the director revealed the two children were only allowed to disembark off from the bus from a designate drop off area that was located at the end of a hallway that was perpendicular to the hallway that led to the cafeteria. Further interview with the director revealed the two school age children would either walk to the cafeteria alone or with school personnel upon arrival and not a staff member with the center. 15 - Activity Areas/Equipment/Materials In Compliance 922 KAR 2:120. 
