## Findings:

General: Based on observation, in the two-to-three-year-old room the diaper changing table is set up against the wall next to the bathroom. When a staff member changes a diaper their back is turned towards the classroom and they cannot adequately supervise the children.

- (1) A licensee shall:
- (a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and
- (b) Protect and assure the health, safety, and comfort of each child.

## Findings:

General: Based on observation, the surveyor walked into the toddler room and said "Hello" and no one answered. The surveyor observed three toddlers in the room. When no one answered the surveyor made a few steps into the room and observed a teacher sitting behind the shelf looking at her phone. The teacher did not see nor acknowledge that someone was in the room. The surveyor stood next to the shelf looking at the teacher to make an eye contact but she did not notice the surveyor. After waiting for approximately one minute the surveyor "Hello" again. The teacher looked up, then the surveyor introduced herself. The teacher then got up and put her phone away. The staff member was not engaged with the children and was not paying attention to the children in her care. This could pose a potential safety risk to the children.

- 2. GED or qualifying documentation from a comparable educational entity; or
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

#### Findings:

General: Based on review of documentation, two staff members (hire dates: 1/24/2022 and 3/7/2022) did not have evidence of a high school diploma, GED, or Commonwealth Child Care Credential on file at the facility.

### 415 - CPR/First Aid Required Training

(8) Each center shall ensure that every staff member has received training on first aid and cardiopulmonary resuscitation (CPR).

#### Findings:

General: Based on review of documentation, three staff members (hire dates: 6/7/2021, 1/24/2022, and 7/20/2020) did not have evidence of completing the required CPR/First Aid training on file at the facility. A review of ECE-TRIS records supports the information found during the survey.

## 922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child-care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

## Findings:

General: Based on review of documentation, the following was found:

- 1.) A staff member hired on 1/24/2022, did not complete the required Orientation training. This staff member has been employed for more than three months.
- 2.) A staff member hired on 9/15/2020, did not complete the required PAHT training within the first year of employment. The course has not been taken as of the day of the survey.
- 3.) A staff member hired on 3/10/2003, completed PAHT training on 4/24/2017; however, did not renew the training due 4/24/2022.
- 4.) Three staff members hired on 6/7/2021, 3/10/2003, and 9/15/2020, did not have evidence of completing 15 hours of annual early care and education training on file.

A review of ECE-TRIS records supports the information found during the survey.

## Findings:

General: Based on review of documentation, it was found in the four-year-old room during the time of the visit there were 10 children but every shelf was turned around and no materials were accessible to the children. The teacher was doing a weather report with the children. Two of the children were trying to turn the shelf to access the materials but they were unable to turn the shelf around.

General: Based on observation, a staff's purse was found in the bathroom/diaper changing area used by two-to-three-year-old, infant, and toddler rooms. This purse was accessible to the children using this bathroom/changing area.

General: Based on observation, the following was found:

- 1.) There was chipped paint and dirty walls in the toddler room and bathroom of the two-to-three-year-old room.
- 2.) The ceiling tiles were stained in the four-year-old room and the big room eating area.

### Findings:

Based on observation, it was found that the daily planned program of activities (lesson plan) posted in the infant and toddler rooms were no longer current. The posted daily planned program of activities was dated for previous week.
