General: Based on observation and interview, a caregiver, 16 years old supervised four (4) infants alone for approximately five (5) minutes.

 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence; and
 - 4. A copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

265 - Health, Safety, Comfort

- (l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on observation, two (2) outlets located in the foyer/entrance, one (1) outlet in the sleep room and one (1) outlet next to the changing table did not contain safety plugs.

270 - Parent Notification

- (m) Notify the parent immediately of an accident or incident requiring medical treatment of a child;

275 - Caregiver Alone

 - 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - 2. Criminal records check required by KRS 199.896(19);
 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on review of documentation and observation, a caregiver hired 6/1/11, had a criminal records check dated 1/22/10. This caregiver supervised five (5) children, fifteen (15) months to two (2) years old, from 9:10 a.m. to 11:00 a.m.

305 - Background checks/discharged

310 - Personnel File

 1. Name, address, date of birth, and date of employment;
 2. Proof of educational qualifications;

 - b. Location;
 - c. Date; and
 - d. Number of clock hours completed;
 5. Every two (2) years, a:
 - a. Statement from a health professional that the individual is free of active tuberculosis; or
 - b. Copy of negative tuberculin results; and
 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - b. Criminal records check required by KRS 199.896(19);
 - c. Criminal records check from any previous state of residence completed once if:
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and
 - d. An address check of the Sex Offender Registry;

315 - Educational Requirements

 1. High school diploma;

Findings:

General: Based on review of documentation, caregivers hired 6/6/12 and 4/5/13, did not have education documents on file.

320 - TB Verification

- (b) Shall provide, prior to employment and every two (2) years thereafter:
 1. A statement from a health professional that the individual is free of active tuberculosis; or

General: Based on review of documentation, caregiver hired 3/8/11, had TB documentation dated 3/9/11. In addition, staff hired 6/6/11, did not have TB documentation on file.

325 - CPR/First Aid Coverage

 - (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.
