General: Based on interviews, the surveyor learned that a staff person has threatened the children by informing them that she would "smack a child's ass", "smack a child in the mouth" and "sit on a child".

385 - Discipline Not In Compliance

922 KAR 2:120. Section 2. Child Care Services.

- (10) A child shall not be subjected to:
- (a) Corporal physical discipline pursuant to KRS 199.896(18);
- (b) Loud, profane, threatening, frightening, or abusive language; or
- (c) Discipline that is associated with:
- 1. Rest;
- 2. Toileting; or
- 3. Food.

Findings:

General: Based on interview, the surveyor found that a staff person smacked a four-year-old child on the buttock and told him to go to sleep. Corporal physical discipline and disciple associated with rest is prohibited.
