#### Findings:

General: Based on Review of Documentation, it was found that a staff person hired 09/15/2014 did not have a completed child abuse and neglect check until 10/01/2014. It was also found that a staff person with a hire date of 10/05/2015 did not complete a child abuse and neglect check until 10/14/2015. These instances are not in accordance with 922 KAR 1:470 which states that a request for a central registry check must be submitted within five (5) working days after the date of employment of an individual.
