Observation of the preschool red room revealed an electrical outlet located under the bulletin board that was not covered. Further observation of the preschool red classroom revealed three (3) electrical outlets located in the library center that was not covered.

General: Based on observation of the main hallway that the children use, a wall contained chipping white concrete. Observation of the pre-k red room revealed the wall above the heating unit was chipping concrete in two (2) areas.



645 - Sink **Not In Compliance**

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Observation of the pre-k white room revealed a sink that had no running hot water. Interview with the staff member in charge revealed the sink has never dispensed hot

Observation of the posted documents in the preschool white room revealed there was not a written plan outlining the course of action in the event of a natural disaster or a manmade disaster. Observation of the posted documents in the preschool red room revealed there was not a diagram and a written plan outlining the course of action in the event of a natural disaster or manmade disaster.
