**922 KAR 2:090. Section 8. General.**  
**(1) A licensee shall:**  
**(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and**  
**(b) Protect and assure the health, safety, and comfort of each child.**

**Findings:**

General: Based on interview, the staff person in charge stated that she viewed cell phone footage of a four-year-old child on his stomach, on the classroom floor with a staff person on top of his back trying to get the child to put hand sanitizer on his hands. Interviews with staff found that the staff person tried for several minutes to get the child to wash his hands after going to the bathroom, but the child kept refusing to do so. The staff person ended up sitting on the floor with the child between her legs trying to put hand-sanitizer on his hands. Staff stated that the child fought with the staff person causing both the staff person and the child to fall over. Staff stated that the child ended up on his stomach and the staff person landed on top of him, which is when the cell phone footage was taken. The staff person in charge stated that she looked the child over and found that he was not hurt.

**922 KAR 2:120. Section 2. Child Care Services.**  
**(11) A child shall not be subjected to:**  
**(a) Corporal physical discipline pursuant to KRS 199.896(18);**  
**(b) Loud, profane, threatening, frightening, humiliating, or abusive language; or**  
**(c) Discipline that is associated with:**  
**1. Rest;**  
**2. Toileting;**  
**3. Play time; or**  
**4. Food.**

**Findings:**

General: Based on interview, the staff person in charge stated that she viewed staff cell phone footage that showed a four-year-old child on his stomach, on the classroom floor with a staff person on top of his back trying to get him to put hand-sanitizer on his hands. Per staff interview, the child had refused to wash his hands at the sink after using the bathroom, so the staff person tried holding him down to put hand-sanitizer on his hands.
