General: Based on observation, the surveyor found eleven (11) children in the preschool classroom with one (1) staff (DOH: 10/7/15). Through interview, staff confirmed she had a total of eleven (11) children with the youngest child being two years old and the oldest being four years old.

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

- (1) Effective with the adoption of this administrative regulation, a director shall:
- (a) Be twenty-one (21) years of age;
- (b) Have a high school diploma, a general equivalency diploma (GED), or qualifying documentation from a comparable educational entity;
- (c) Not be employed in a position other than an on-site child care director, or director of multiple facilities, during the hours the child-care center is in operation;

# Findings:

General: Based on interview, the surveyor found that the child care center director (DOH: 4/1/04) is employed at Cheddars during the hours the child care center is in operation. Through interview, the director (DOH: 4/1/04) confirmed working at Cheddars on Monday through Friday during the lunch shift. A manager at the restuarant confirmed that the director (DOH: 4/1/04) typically works Monday through Friday during the lunch shift. The center's hours of operation are Monday through Friday from 6:00 a.m. - 12:00 a.m.

(1) An infant shall sleep or nap on the infant's back unless the infant's health professional signs a waiver that states the infant requires an alternate sleeping position.

#### Findings:

General: Based on observation, the surveyor found an six-month-old infant sleeping in a bouncy seat. The infant was observed sleeping in the bouncy seat throughout the surveyor's visit at the center.

435 - Bedding/Toys in Crib Not In Compliance

922 KAR 2:120. Section 6. Sleeping and Napping Requirements.

- (3) Rest time shall include adequate space specified by the child's age as follows:
- (a) For an infant:
- 3. No loose bedding; and
- 4. No toys or other items except the infant's pacifier;

#### Findings:

General: Based on observation, the surveyor observed a eight-month-old infant sleeping in a crib with a loose blanket and a boppy pillow. Based on interview with the infant classroom teacher, the child does not have permission from the parents or physican to use a boppy pillow in the crib.
