**Findings:**

General: Based on Observation, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Observation of the Preschool 1 Room revealed two (2) children in the bathroom waiting for assistance, out of the scope of vision of the staff. Continued observation revealed the staff person entered the bathroom to provide assistance to one (1) of the two (2) children while leaving the remaining eight (8) children out of the scope of vision at approximately 2:40 p.m..

#### Findings:

General: Based on Review of Documentation, and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Review of staff files revealed the absence of written documentation to verify that individuals with the hire dates of 4/15/15, 1/29/15 and two (2) on 5/15/15 had completed a high school diploma, a GED or a Commonwealth Child Care Credential. Interview with the director revealed that the documentation was not available to be presented for review at the time of the inspection.
