- (11) To qualify for a preliminary license, or maintain a regular license, a child-care center shall:**  
**(g) Have a director who meets the requirements listed in 922 KAR 2:110.**

**Findings:**

Based on record review, the facility failed to have a director who meets the requirements listed in 922 KAR 2:110. During an interview with the interim director, it was revealed that the former director resigned on 8/1/2015. The interim director stated she has not yet submitted the required paperwork for the director change because she has not completed six (6) hours of early care/education training. Therefore, the facility has been operating without a formally named director since 8/1/15.

**175 - Change of Director**

**Not In Compliance**

**922 KAR 2:110. Section 6. Reports.**

- (3) A licensee shall report to the cabinet within one (1) week:**  
**(a) Any resignation, termination, or change of director; and**  
**(b) The name of the acting director who satisfies the requirement of Section (4) of this administrative regulation.**

**Findings:**

General: Based on interview, the facility failed notify the cabinet within one (1) week of a director change. Based on an interview with the interim director, the former director resigned from the facility on 8/1/15. The interim director stated she still needs to complete six (6) hours of early care/ education training before submitting the required paperwork for a director change.
