## 922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1  $\frac{1}{2}$ ) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

### Findings

General: Upon request, the staff in charge did not present verification that the records of the employees with the hires dates of 08/01/2005,08/01/2013,10/01/2018,08/22/2018 and 09/20/2008 had met the requirement of fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment. Continued review revealed the employee with the hire date of 12/01/2014 had not met the requirement of updating pediatric abusive head trauma training. Review of documentation in the ECE-TRIS training system revealed the above-mentioned employees had not met the training requirement.
