**(1) Child-care center staff:**

- (a) **Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:**
  - 1. **High school diploma;**
  - 2. **GED or qualifying documentation from a comparable educational entity; or**
  - 3. **Commonwealth Child Care Credential as described in 922 KAR 2:250;**

General: Based on interview and review of documentation, a staff member hired 03/21/22, did not have education verification on file.

**435 - Training**

**922 KAR 2:090. Section 11. Staff Requirements.**

**(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:**

- (a) **Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child-care program;**
- (b) **Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and**
- (c) **Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.**
- (17) **A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.**

General: Based on interview and review of documentation, a staff member hired 05/20/19, did not complete any hours of training during a subsequent year of employment.

General: Based on interview and review of documentation, a child enrolled on 02/12/20, had an immunization certificate on file that was valid until 02/25/22.

**(1) A child-care center shall maintain:**  
**(c) Daily attendance records documenting the arrival and departure time of each child, including records that are required in accordance with 922 KAR 2:160, Section 13, if a child receives services from the child-care center through the Child Care Assistance Program;**

General: Based on observation, interview and review of documentation, eight (8) children were present on 04/21/22 and only six (6) had a arrival time documented.
