#### Findings:

General: Based on review of documentation, a staff hired on 05/07/13, had a child abuse/neglect check on file with no documented results. Also, an adult in the home (DOB: 10/01/91) was in the presence of the children but did not have a criminal records check and a child abuse/neglect check submitted. Based on interview, the adult had been in the home for approximately three (3) weeks.
