General Requirements.</b>  <b>(11) While bottle feeding a child, the:</b>  <b>(a) Child shall be held; and</b>  <b>(b) Bottle or beverage container shall not be:</b>  <b>1. Propped;</b>  <b>2. Left in the mouth of a sleeping child; or</b>  <b>3. Heated in a microwave.</b></p>	
<b>Findings:</b>	
General: Based on interviews, it was found that children enrolled in Infant classrooms are not always held during bottle feeding or placed in an appropriate feeding furnishing.	
A staff member in the Beginners Classroom, explained that they hold the children who cannot hold their own bottle during feeding, but children who are able to hold their own bottle are placed in bouncy seats. A staff member sits in a rocking chair and watches the children while they drink their bottle.	
A staff member in the Crawlers Classroom, explained that sometimes when two children need to be fed a bottle at the same time; staff place the children on the floor with their bottle. A staff member sits between the children while they drink their bottle.
