Findings:

General: Based on Observation, a can of Glade Air Freshener was observed sitting on a low table in the area where the children play. The label on the can indicates to "Keep Out of the Reach of Children". During a tour of the bathroom a razor and a can of shaving cream were found in the second drawer in the cabinet where the sink is located.

245 - Guns/Ammunition

General: Based on Interview, it was found that the provider changes diapers in the living room. There is not a sink in the living room and the closest sink is in the bathroom located down the hall.
