#### **Findings:**

General: Based on Interview, at the time of the survey the staff person in charge indicated that her son, who is in college but does not live in the home, and her parents who live in the house across from her are sometimes present when the children are being cared for. However, the staff person in charge had not submitted an application and received the results for a criminal records check and child abuse or neglect check for these adults. At the time of the survey the staff person in charge indicated that her mother was napping in a back bedroom. It was also found through interview that the provider's son had been at the home prior to the surveyor's arrival.
