General: Based on Observation, in the smaller room used for child care there were toys, boxes and various other items thrown all over the floor. An interview with the provider found that she uses this room for the older children and that the children get the toys out and throw them on the floor. There was an additional area used for care for the smaller children. During a tour of the kitchen there was a large number of dirty dishes with dried food on them piled in the sink. An interview with the provider found that her dishwasher had broken. The provider also indicated that some of the dishes in the sink were left over from dinner the night before.


