Review of documentation and interview revealed the provider failed to coordinate at least one (1) annual activity involving parental or family participation. ## Findings:

General: Based on interview and review of documentation, the family child care home failed to comply with regulatory requirements regarding animals. Interview with the family child care provider revealed the presence of two (2) dogs in the child care home at the time of survey. Review of three (3) children's files revealed the absence of written parental consent for the dogs to be in the presence of the children. Interview with the provider revealed she failed to obtain written parental consent for these three (3) children.
