General: Based on review of documentation and interview, a child abuse/neglect check was not available for the assistant hired 9/27/10. Interview with the provider determined the assistant worked two (2) days each week.

General: Based on review of documentation, the assistant hired 9/27/10, did not have documentation she had completed first aid and CPR training. Observation and interview determined the assistant supervised a toddler from 8:30 a.m. to 9:00 a.m. on 5/20/13, when the provider was away from the home.

General: Based on review of documentation, the assistant hired 9/27/10, had not completed nine (9) hours of cabinet approved training. Interview with the provider, the assistant supervised children two (2) days each week while the provider was away from the home.
