General: Based on review of documentation and interview, the criminal records check and child abuse/neglect check were not maintained for the adult who lived in the home. Interview with the provider determined she completed the checks but could not provide the documentation.

Findings:

General: Based on observation, a bottle of Glade carpet cleaner was on a toy shelf. Two (2) razors were in the bathtub. A bottle of Clorox wipes and two (2) cans of Mr. Clean Scrubbing Bubbles was on a shelf behind the toilet. These items were accessible to the children. Also, a car battery was on a shelf beside the exit/entrance door. A pair of adult-size hedge clippers was stored on top of the children's cubbies behind the exit/entrance door.

245 - Guns/Ammunition

General: Based on observation, a ten (10) month old child did not wash her hands after she was diapered.
