General: Based on observation, a bottle of Glade carpet cleaner was on a toy shelf. Two (2) razors were in the bathtub. A bottle of Cloroz wipes and two (2) cans of Mr. Clean Scrubbing Bubbles was on a shelf behind the toilet. These items were accessible to the children. Also, a car battery was on a shelf beside the exit/entrance door. A pair of adult-size hedge clippers was stored on top of the children's cubbies behind the exit/entrance door.

245 - Guns/Ammunition In Compliance

General: Based on observation, the provider wore gloves but did not wash her hands before she diapered a child.
