- 2. Empty plastic bags were observed in an unlocked cabinet located under the kitchen sink. The items were accessible to the children.
- 3. Air fresheners were observed on the coffee table and plugged into electrical outlets in the living room. Through interview, the surveyor learned that children have access to the living room: therefore, the air fresheners were accessible to the children.
