- (10) The minimum number of adult workers in a child-care center shall be sufficient to ensure that:
- (a) Minimum staff-to-child ratios in accordance with 922 KAR 2:120 are followed;
- (b) Each staff person under eighteen (18) years of age and each student trainee are under the direct supervision of a qualified staff person who meets the requirements of this section; and
- (c) Unless providing care with a qualified staff person, a person under the age of eighteen (18) shall not be counted as staff for the staff-to-child ratio.

### Findings:

General: Based on observation, review of documentation, and interview, the child care center failed to comply with staffing requirements. At 9:25 am, a staff member hired 4/12/18 was observed supervising a class comprised of children as young as four-years old and as old as nine-years old in the gym area. This staff member was the sole caregiver of these children. In addition, at 11:30 am, the aforementioned staff member was the sole caregiver for the same group of children, which were at this time located in the art room. Review of staff files and interview with the staff inc charge revealed the staff member was only seventeen-years-old. Consequently, the staff member hired 4/12/18 was not under the direct supervision of a qualified staff person at all times during the survey while she was supervising children. Moreover, the staff in charge acknowledged the aforementioned staff member was seventeen years of age and was working alone by mistake.
