General: Based on observation and interview, the surveyor entered the infant classroom approximately 11:30 am and proceeded to the infant room bathroom. Surveyor observed a changing table adjacent to the door inside of the rest room. HSS asked the teacher (hire date 12/16/16) how she is able to supervise the children when she is in the bathroom and the teacher stated that she will put the infants in their cribs or move to them to the end of the room that the bathroom is on. This arrangement does not allow for the activity areas to be supervised by staff when changing diapers.

General: Based on observation and review of documentation, staff hired 6/27/16 did not have evidence of current TB screening in file.

General: Based on observation and review of documentation, The following staff did not have the required (15) hours of training per review of TRIS: Hire dates - 6/4/1990, 5/8/12, 8/8/14, 10/16/14, 4/21/10, 2/1/17, 5/31/18, 5/15/14, 4/3/18, 6/27/16, 5/17/18, 6/4/107.

The following staff did not have evidence of current PAHT: Hire dates - 5/8/12, 6/27/16, 3/5/18.

The following staff files did not contain evidence of six (6) hours of cabinet approved orientation: DOH 8/22/18.

General: Based on observation, during a walk through of the facility the surveyor found the Preschool room contained Lysol wipes stored on the bottom shelf in the supply storage area across from the library books.

General: Based on observation, HSS observed a white shelf in the Preschool room by the storage area that was cracked across the top.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

#### Findings:

General: Based on observation, HSS ran water from sink in one (1) year old room for approximately 20 seconds and water did not reach minimum temperature of ninety (90) degrees Fahrenheit.

### 685 - Diaper Changing Area/Surface

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (10) When a child is diapered, the child shall:
- (b) Be placed on a surface that is:
- 1. Clean;
- 2. Padded;
- 3. Free of holes, rips, tears, or other damage;
- 4. Nonabsorbent:
- 5. Easily cleaned; and
- 6. Free of any items not used for diaper changing.

### Findings:

General: Based on observation and interview, there was a cloth towel on the changing table. The teacher (hire date 8/12/16) was asked if she uses the towel in question to clean the changing table and the teacher stated that she did. This practice is unsanitary and increases risk for spread of bacteria.

700 - Children's Individual Items

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (14) Combs, towels or washcloths, brushes, and toothbrushes used by a child shall be:
- (a) Individually stored in separate containers; and
- (b) Plainly labeled with the child's name.

### Findings:

General: Based on observation, there was one bottle and one sippy cup in the one year old classroom that were not individually labeled with child's name.



#### First Aid/Medication

730 - Medication Not In Compliance

922 KAR 2:120. Section 7. First Aid and Medicine.

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child unless the medication is:
- 1. A first aid supply and is maintained in accordance with subsection (1) of this section;
- 2. Diaper cream, sunscreen, or toothpaste. Diaper cream, sunscreen, or toothpaste shall be inaccessible to a child;
- 3. An epinephrine auto-injector. A licensed child-care center shall comply with KRS 199.8951 and 311.646, including:
- a. An epinephrine auto-injector shall be inaccessible to a child;
- b. A child-care center shall have at least one (1) person onsite who has received training on the administration of an epinephrine auto-injector if the child-care center maintains an epinephrine auto-injector;
  - c. A child-care center shall seek emergency medical care for a child if an auto-injector is administered to the child; and
- d. A child-care center shall report to the child's parent and the cabinet in accordance with 922 KAR 2:090, Section 12(1)(b) if an epinephrine auto-injector is administered to a child; or
- 4. An emergency or rescue medication for a child in care, such as medication to respond to diabetic or asthmatic condition, as prescribed by the child's physician. Emergency or rescue medication shall be inaccessible to a child in care;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the medication's expiration date has passed.

#### Findings:

General: Based on observation and interview, there was a bag in the Two (2) and Three (3) year old room containing several unlabeled bottles of sunscreen. HSS inquired with teacher (DOH 8/8/14) and teacher stated that the sunscreen belongs to the children.

- 1.) Grime build-up and residue from removed tape on refrigerator in infant classroom.
- 2.) Oven in 1 year old classroom dramatic play had an excessive amount of worn down/ chipped paint exposing the wood on toy.
