Findings:

General: Based on Review of Documentation, three (3) staff did not complete 15 hours of cabinet-approved early care and education training during their completed training year. A staff hired 11/1/83 completed twelve (12) hours of training from 11/01/14 to 11/01/15. A staff hired 2/1/14 completed nine (9) hours of training from 2/01/15 to 2/01/16. A staff hired 12/01/14 completed six (6) hours of training from 12/01/14 to 12/01/15. The ECE-TRIS record and the on site staff files were reviewed.
