General: Based on observation, The child care center director failed to comply with regulatory requirements in regard to health, safety and comfort of children in care. A daycare teacher smacked a child on the hand/arm multiple times, because the child was hitting his tray. Interviews confirmed that the staff member confessed to hitting the child on the arm as a way to get him to stop. The staff member cares for the child at home away from the center and is used to disciplining him in that manner.
