**Findings:**

General: Based on observation during a tour of the certified child care home, the surveyor found the following:

1. Covers had been placed over the windows to shield the light in the rooms that are used by the children at nap time. The rooms were too dark to see the children, creating a risk for their safety.
2. The surveyor found that a plunger had been placed beside the commode in the restroom that is used by the children. The plunger was accessible.
3. The surveyor observed that laundry had been piled on the floor in front of the washing machine. Through interview, the surveyor learned that the laundry was soiled and was accessible to the children.
4. The surveyor found that a tile was hanging down from the ceiling located near the crib where an infant child sleeps.
5. The surveyor observed that portions of the sheet rock had been removed in the restroom that is used by the children. The area of concern is located on the walls near the floor in front of and beside the commode and is accessible to the children.
