1. A tree that appeared to have fallen and was placed on the ground near two (2) play houses.	
2. A white bucket placed beside the back of the providers home that stated "Proform" on the front of the bucket and had a Warning sign on the side of the bucket that stated, "Children can fall into bucket and drown."	
3. A loose garden hose placed on the ground near the back of the providers home.	
4. A small play house that appeared broken on the playground.	
During interview, the provider stated that the playground has not been in use by the children due to weather. The provider stated that the tree fell onto the playhouse due to the recent winter storm. The provider stated that she would have the items mentioned moved as soon as possible.
