### **Findings:**

General: Based on interview and review of documentation, it was found that one staff member hired 11/30/2020, did not have proof of a criminal records check on file at the facility. The staff member had been previously employed at another facility, where a KARES background check had been run and the staff member was found eligible for hire; however, the staff member had a break in employment, requiring an updated criminal records check. Upon being hired at this facility, the staff member had a central registry check (CAN) completed, but not a criminal records check. The staff member was not working alone during the time of the inspection.

General: Based on observation, this regulatory requirement was not met. The following was found:

1. The bathroom in the Butterfly Fish Room contained a section of linoleum tile that was not secured to the floor. There was a gap around the tile where it shifted.

2. The Angelfish Room contained a small hole in the drywall in the dramatic play area. In addition, next to the hole in the wall there was a small area of chipped paint.
