(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and
(b) Protect and assure the health, safety, and comfort of each child.

Findings:

General: Based on observation, in the Jellyfish room, there was a loose cord going up to a bubble machine on a high shelf. In addition, there were chairs stacked on a table in the corner. Both of these are safety hazards to the children in care.

2. GED or qualifying documentation from a comparable educational entity; or
3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on review of documentation, staff member hired 3/21/2022, had a transcript in their personnel file that did not list a date of graduation. The staff member is not currently enrolled in high school. A diploma was not available for review.
