- a. Ensures the child is within scope of vision and range of voice; or
- b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on Observation, and interview, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Based on a review of documents, a staff member hired on 06/17/14, had a substantiated child neglect found on the registry. A written statement from the staff in charge, and a phone interview with the staff in charge revealed that said staff person was working alone with children between 06/17/14 and 07/09/14.

10 - Children Protected **Not In Compliance**

922 KAR 2:120. Section 2. Child Care Services.

(3)(a) Each center shall maintain a child-care program that assures each child will be:

2. Protected from abuse or neglect.

140 - Staff Conviction/Substantiation

Findings:

General: Based on Review of Documentation, the child care center failed to maintain adequate supervision in accordance with regulatory requirements. Review of documentation revealed that on 06/26/14, 06/27/14, 06/30/14, and 7/7/14 a staff who was later identified as having a substantiated Child Abuse and Neglect Check was working alone with children. A phone interview with staff in charge, confirmed that the said staff person was working alone with children.

General Administration

- (2) A child-care center shall not employ a person:
- (a) Convicted of, or who entered an Alford or guilty plea to, a crime pursuant to 922 KAR 2:090, Section 6(6);
- (b) Found by the cabinet to have abused or neglected a child, pursuant to 922 KAR 1:470;
- (c) Placed on the Sex Offender Registry; or
- (d) Determined by a physician to have a health condition that renders the person unable to care for children.

- (5) An individual described in subsection (4) of this section shall:
- (a) Submit to background checks described in paragraph (b) of this subsection;
- (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
- 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
- 2. Criminal records check required by KRS 199.896(19);
- 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
- 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, the child care center failed to maintain employee records in accordance with regulatory requirements. Based on a review of documentation, staff member with a hire date of 06/17/14 revealed a substantiated finding of child neglect from the Central Registry Check. Based on a phone interview with staff in charge, said staff did work alone with children on 06/26/14, 06/27/14, 06/30/14, 07/07/14.
