 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

General: Based on Review of Documentation, it was found that the file for a substitute worker hired on 7-28-07 did not contain evidence of an annual performance evaluation being completed.

Findings:

General: Based on Observation, it was found that 1) employees hired on 2-9-15 and 10-19-15 were working together with ten (10) school age children while they were upstairs in the computer lab. The employee hired on 2-9-15 did not have the results of a central registry check on file. The employee hired on 10-19-15 did not have the results of a criminal records check on file. These employees were alone with the children for approximately thirty (30) minutes during the survey; 2) an employee hired on 11-2-15 did not have the results of a central registry check, criminal records check or Ohio or FBI criminal records check on file. This employee was observed to be working alone with eight (8) school age children in the homework room.

280 - Altered/Falsified Records

 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, it was found that 1) the file for an employee hired on 9-30-15 contained the results of a central registry check that was signed by the employee on 10-13-15. This date is not within five (5) days of the date of hire as required by the regulation; 2) this same employee's file contained evidence indicating that a criminal records check was requested and received on 10-15-15. This date is not prior to or on date of hire as required by the regulation; 3) the file for an employee hired on 10-7-15 contained evidence indicating that a criminal records check was requested and received on 10-15-15. This date is not prior to or on date of hire as required by the regulation; 4) this same employee's file contained evidence indicating that the employee lived in Idaho within the last five (5) years. The file did not contain evidence of an Idaho criminal records check or an FBI check being completed. This employee was not observed to be alone with the children; 5) the file for an employee hired on 10-19-15 contained evidence of the submission for, but not the results of a criminal records check. This employee was observed to be working with another staff person who did not have all of the required background checks on file; 6) the file for an employee hired on 2-9-15 did not contain the results of a central registry check that was requested on 1-12-15. This employee has been employed for more than the allowed ninety (90) days per the regulation. She was also observed to be working with another staff person who did not have all of the required background checks on file; 7) the file for an employee hired on 11-2-15 did not contain the results of a central registry check, criminal records check or Ohio or FBI criminal records check. This employee was observed to be working alone with children in the homework room.

305 - Background checks/discharged

 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
 - (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - b. Criminal records check required by KRS 199.896(19);
 - c. Criminal records check from any previous state of residence completed once if:
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and
 - d. An address check of the Sex Offender Registry;

315 - Educational Requirements

 - (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
 1. High school diploma;
 2. GED or qualifying documentation from a comparable educational entity; or
 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on Review of Documentation, it was found that two (2) employees did not have evidence of a high school diploma, GED or Commonwealth Childcare Credential on file at the facility.

320 - TB Verification

- (1) Child-care center staff:
 - (b) Shall provide, prior to employment and every two (2) years thereafter:
 1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

The wall material where the baseboards should have been was found to be crumbling and falling away from the wall in chunks; 3) the brown paint of the doors and door frames was found to be chipped and peeling in multiple places. The staff person in charge stated that she believes the school has been asked to fix some of the problems, but they have yet to do so.

It should be noted that issues with light covers being broken or missing were cited during the 1-16-14 and 12-10-14 relicensure surveys.

General: Based on Observation, it was found that 1) there were four (4) stained ceiling tiles in the main classroom area and one (1) stained ceiling tile in the homework room; 2) in order to enter and exit the classroom space used by the facility, the children have to pass through a room that is no longer used by the school. At least eleven (11) of the ceiling tiles as well as a metal vent in this area are buckled and sagging from the ceiling at approximately a 45 degree angle; 3) in the main classroom area, a ten (10) inch triangular area of tile is missing from the floor, exposing the subfloor beneath. In the main classroom and the homework room, several other small areas of tile were found to be missing or broken, exposing the subfloor beneath; 4) in the girls' bathroom, a one (1) foot by two (2) feet area of paint had been peeled from the wall. Flaking paint was observed to be around the edges of this area and flakes of paint were observed to be on the floor; 5) in the room the children pass through to get to the classroom area large areas of the walls were found to be crumbling into a sand-like material. Large areas of paint were observed to be peeling from the wall as well; 6) in the main classroom area, large sections of paint were observed to be peeling off of the walls in multiple places; 7) in the main classroom area, several spots on the walls were found to be crumbling into a sand-like material; 8) in the homework room, the paint was found to be peeling away in large pieces in multiple places including the walls, ceiling and window sills; 9) in the homework room, the wall behind the chalkboard was found to be crumbling into a sand-like material. The staff person in charge stated that she believed the school had been asked to fix the rooms, but had not responded. It was also found that posters and strategic furniture placement had been used to hide some of the wall damage rather than fix the issues. It should be noted that the issues regarding the walls and paint were cited during the relicensure surveys conducted on 1-16-14 and 12-10-14.
