- (f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;
- (g) Supervise staff conduct to ensure implementation of program policies and procedures;

### Findings:

General: Based on review of documentation and interview, the volunteer policy stated all volunteers working in the classroom with the children must complete safe sanctuaries training, background checks, fingerprinting and a TB skin test. This policy was not implemented when a volunteer, start date 10/01/14, did not have TB documentation available for review.

# 922 KAR 2:090. Section 10. Director Requirements and Responsibilities.

(1) A director shall:

(I) Assure the health, safety, and comfort of each child;

### **Findings**

General: Based on observation, an extension cord to the microwave, and a cord to the heating/air window unit in room 12; the DVD cord in room 13; the cord to the heating/air window unit in room 10; the cord to the circulating pedestal fan and a cord to the heating/air unit in room 11, were accessible to the children. A step ladder was propped against the wall, beside the hand washing used by the children in room 9; therefore, the ladder was not properly secure.

### Findings:

General: Based on review of documentation and interview, a volunteer (10/01/04), did not have a TB skin test or physician statement on file, per the center volunteer policy.

### 410 - Training Not In Complia

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;

520 - Inaccessible Items

General: Based on observation and interview, the planned program of activities for the toddlers' room included 9:00 a.m. until 9:15 a.m., snack was scheduled and 9:15 a.m. until 10:00 a.m., craft was scheduled. At 10:20 a.m., the snack was not served to the children, and the children's craft was not completed; therefore, the program of activities was not followed in room 13.

General: Based on observation, four (4) safety straps were missing from four (4) high chairs in room 13. A sign posted to the back of the high stated, "Prevent serious injury or death from falls or sliding out, always secure child in the in the restraint."

Also, three (3) children sat in high chairs with straps but the safety straps were not used in room 13.

General: Based on review of documentation, a child enrolled 04/01/18, had an immunization, on file, that did not include a date of expiration. A note on the immunization documentation stated "not up to date no other immunizations at this time."

General: Based on review of documentation and interview, the earthquake drill for the 4th quarter of 2018, was practiced, but the names of the children who participated, time and date were not documented.
