922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:
- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.
- (17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. A staff member hired on 10/14/2020, did not have written evidence of completing the six-hour cabinet-approved orientation training within the first three months of employment. The ECE-TRIS system was reviewed.

- (4) The child-care center shall provide a daily planned program:
- (a) Posted in writing in a conspicuous location with each age group and followed;

- (c) That provides experience to promote the individual child's physical, emotional, social, and intellectual growth and well-being; and
- (d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities includina:

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

- 1. The Crawlers Room did not have a dated lesson plan posted.
- 2. The Infant Room did not have a posted lesson plan.
- 3. The Tots Room did not have a posted lesson plan.

Premises Not In Compliance

- (7) The following shall be inaccessible to a child in care:
- (a) Toxic cleaning supplies, poisons, and insecticides;
- (b) Matches, cigarettes, lighters, and flammable liquids; and
- (c) Personal belongings and medications of staff.

Findings:

General: Based on observation, this regulatory requirement was not met. The following was found:

- 1. The women's hall bathroom that is used by the children, contained an insect glue trap on the floor behind the door. The trap was accessible to the children.
- 2. The Tots Room (one-year-olds) contained an unlocked cabinet under the diaper-changing table that contained numerous diaper ointments. This area was accessible to the children. The diaper ointments were labeled "keep out of reach of children".

(1) The premises shall be:

Findings:

General: Based on observation, this regulatory requirement was not met. The following was found:

- 1. The Crawlers Room contained a dusty vent on the wall.
- 2. The Infant Room contained dried, rusty, water stains on the wall behind one of the cribs.
- 3. The Pre-K 2 B Room contained a section of missing baseboard next to the home living area.
- 4. The Pre-K 2 B Room contained a stained ceiling tile above the home living area.
- 5. The bathroom in the Busy Bees Room contained a missing ceiling tile.
- 6. The bathroom in the Busy Bees Room contained a missing cover over the exhaust fan in the ceiling.
- 7. The Tots Room contained a dusty vent on the wall.

General: Based on observation, this regulatory requirement was not met. The Busy Bees Room contained chipped paint on the wall near the library area and the wall by the science area.

Findinas:

General: Based on observation, this regulatory requirement was not met. The following was found:

- 1. The Infant Room contained tape residue on several of the cribs. The residue was located on the Plexiglass area of the cribs.
- 2. The Pre-K 1 Room contained areas of trim that were coming off of the sides of the handwashing sink.
- 3. The Busy Bees Room contained a mirror in the library area that contained scuffs and smudges.

Findings:

General: Based on observation, this regulatory requirement was not met. There was not a thermometer inside the freezer in the Crawlers Room; therefore, the temperature of the freezer could not be determined. The freezer was storing breastmilk and teethers for the children. A freezer shall be kept at zero degrees Fahrenheit or below.

- (iii) Preferred hospital;
- c. The name of each person who is designated in writing to pick-up the child;
- d. The child's general health status and medical history including, if applicable:
- (i) Allergies;
- (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and
- (iii) Permission from the parent for third-party professional services in the child-care center;
- e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;
- f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on observation and review of documentation, this regulatory requirement was not met. The following was found:

- 1. A child's enrollment information did not include signed authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence.
- 2. A child's enrollment information did not include a preferred hospital. This area was left blank on the enrollment form.

- 3. The animal is certified as vaccinated against rabies; or
- (b) Except in accordance with subsection (3) of this section.

Findinas:

General: Based on observation, interview and review of documentation, this regulatory requirement was not met. The Preschool Room contained a fish. Eleven of the seventeen children enrolled in this classroom had written parental consent to be in the presence of the fish.
