<p><b>Findings:</b>                      During the investigation it was found that a three-year-old child was left alone and unsupervised in the gym for a few minutes on March 16, 2022, at approximately 5:00 pm.                      On March 16, 2022, the preschool class was transitioning from the gym to the playground. A staff member stated that she was positioned in the front of the line and a second staff person was positioned in the back of the line as they walked to the playground. After they reached the playground, a third staff member brought the three-year-old child outside and told the staff that she had found him alone in the gym. Based on interviews, the surveyor found that the staff forgot to count the children during the transition.</p>
