General: Based on interview, the child care center director failed to assure compliance with regulatory requirements. Interview with director and staff revealed that on 9/13/17 a fouryear-old child with enrollment date 2/22/16 was forcibly placed in an infant high chair and secured with the feeding tray restricting his movement for discipline. Continued interviews revealed the child with enrollment date 2/22/16 remained restricted in the high chair for fifteen (15) – thirty (30) minutes. Interviews revealed the child with enrollment date 2/22/16 suffered a scratch to his neck as a result of the incident.

General: Based on interview, the child care center failed to comply with regulatory programming requirements. Interview with director and staff revealed a four-year-old child with enrollment date 2/22/16 was disciplined by placing the child in an infant high chair for fifteen (15) – thirty (30) minutes. Continued interview revealed the high chair feeding tray was used to restrict the child's movement as discipline.
